FACTS	WHAT DOES CERTIFIED FEDERAL CREDIT UNION ("FINANCIAL INSTITUTION") DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us This information can include: Social Security number and credit card or other debt Account transactions and payment history Credit history and transaction history When you are no longer our Member, we continue to share your information as described in this notice.
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons the Financial Institution chooses to share; and whether you can limit this sharing.

What we do	
How does the financial institution protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does the financial institution collect my personal information?	We collect your personal information, for example, when you Open an account or deposit money Pay us by check or apply for a loan Use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only sharing for affiliates' everyday business purposes — information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. Our Financial Institution has no affiliates
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Our Financial Institution does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include an insurance company.

Other Important Information

California Residents: California law may provide additional rights that allow you to opt out of certain sharing we may do with outside companies we contract with for other financial products and services. For this, we provide a separate notice entitled "Important Privacy Choices for Consumers" describing these rights.

Your Rights

You have the following right to restrict the sharing of personal and financial information with outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products or services.

Your Choice

Restrict information sharing with other companies we do business with to provide financial products and services. Unless you say "No," we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.
